The Previous Party shall deliver to Scottish Hydro Electric Power Distribution a copy of this agreement within five Business Days of the date of this deed

#### 4 RELEASE

4.1 The parties agree that from the Assignment Date the Previous Party no longer has any rights in relation to the ECCR Payment

#### 5 COSTS

5.1 Each party shall pay its own costs and expenses incurred in connection with the negotiation, preparation, execution and performance of this deed (and any documents referred to in it).

#### 6 THIRD PARTY RIGHTS

6.1 Except as expressly provided elsewhere in this deed, a person who is not a party to this deed has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce or to enjoy the benefit of any term of this deed. This does not affect any right or remedy of a third party which exists, or is available, apart from that Act.

### 7 GOVERNING LAW AND JURISDICTION

- 7.1 This deed and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of Scotland.
- 7.2 Each party irrevocably agrees that the courts of Scotland shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with this deed or its subject matter or formation.
